Social Work Licensing Basics

The purpose of licensing and certification in social work is to assist the public through identification of standards for the safe professional practice of social work. Each jurisdiction defines by law what is required for each level of social work licensure. Typically, there are four categories of practice that jurisdictions may legally regulate.

- **Bachelors:** Baccalaureate social work degree upon graduation;
- **Masters:** Master's degree in social work (MSW) with no post-degree experience;
- **Advanced Generalist:** MSW with two years post-master's supervised experience; and
- **Clinical:** MSW with two years post-master's direct clinical social work experience.

Within the profession it is important to note that there are additional designations and certifications available to practitioners. For more information regarding these designations consult with your state licensing board and NASW.

TX Licensure Process & Timeline

Step 1: Complete Application Packet

Step 2: Take Jurisprudence Exam Online (\$40.00)

Step 3: Submit

- Application (see link above)
- Fee (\$91.00)
- Necessary documentation of qualifications
 - Letter from Dean Garland (submitted by the School the first week of your final semester a copy of which is also placed in your folder in the student lounge)
 - Official Transcript (requested from Academic records upon graduation)
 - Jurisprudence Exam: submit proof of completion
- Examination Security Information Form

Approval (approx. 3-4 weeks from submission) to sit for the examination is communicated to ASWB and the applicant in writing when all qualifying information has been received and approved by the Board.

TX Licensure Process & Timeline

Step 4: Register with the Association of SW Boards (ASWB)

- Online: www.aswb.org
- Or by phone: 1.888.579.3926
- Exam Registration Fee: \$230.00

ASWB will send an authorization letter to applicants that includes an authorization # , list of approved testing sites and contact info.

Step 5: Schedule Test (Site and date)

Step 6: Exam

- Bring ASWB authorization letter
- Government issued photo ID
- You will receive notice of your score immediately upon completion of the exam

Once ASWB receives your passing score from the exam site you will receive your certificate, 2 copies of your license card (approx. 14 days), and renewal information by mail. Complete process takes approximately 3 months.

Texas Exam Details: Format

- Beginning in 2011 for the Bachelors, Masters, and Clinical examinations, and in 2012 for the Advanced Generalist examination, the tests will use 150 questions to measure competency across 4-5 content areas.
- Exam takers will have 4 hours to take the exam
- Exam taken on computer terminals at various locations (list sent to you once you qualify to take the exam)
- If special accommodations are needed to take the exam, the candidate may request them using the form in the candidate handbook.
- States and provinces will require a “70”, a “75” or a “pass” just as they do now.

Sample Exam Questions

- **Bachelors Examination**

The primary purpose of a service plan is to:

- **Masters Examination**

A client who has received services for several years in a dialysis unit appears for a routine visit.
