Profile of First-Time Freshmen Fall 2011 and Fall 2012

This report contains descriptive information about first-time freshmen for Fall 2011 and Fall 2012. Included in this report is information about the following topics:

Fall 2012

The class of 3,254 first-time freshmen includes students who entered the University during Summer 2012 and Fall 2012. Sixty-one percent of the class are females, and 34 percent are from racial or ethnic minority groups. Students with a Baptist religious affiliation comprise 31 percent of the group, while 15 percent are Non-Denominational and 16 percent are Catholic.

Ninety-seven percent of these students are United States citizens, while 90 (2.8%) are resident or nonresident aliens representing 29 foreign countries. By domicile, as reflected in the students' home addresses, the class of first-time freshmen is comprised of students from 42 states. Seventy-four percent of the first-time freshmen are from Texas.

Among students with high school class ranking, 72 percent were in the top quartile of their high school graduating classes. The score range for the middle fifty percent of the entering first-year class is 1140 – 1320 with a mean score of 1234 for the SAT and 24 – 29 with a mean score of 26.9 for the ACT examination.

Fall 2011

The class of 3,033 first-time freshmen includes students who entered the University during Summer 2011 and Fall 2011. Fifty-nine percent of the class are females, and 33 percent are from racial or ethnic minority groups. Students with a Baptist religious affiliation comprise 33 percent of the group, while 15 percent are Non-Denominational and 16 percent are Catholic.

Ninety-seven percent of these students are United States citizens, while 91 (3.0%) are resident or nonresident aliens representing 32 foreign countries. By domicile, as reflected in the students' home addresses, the class of first-time freshmen is comprised of students from 45 states and the District of Columbia. Seventy-four percent of the first-time freshmen are from Texas.

Among students with high school class ranking, 74 percent were in the top quartile of their high school graduating classes. The score range for the middle fifty percent of the entering first-year class is 1140 – 1320 with a mean score of 1236 for the SAT and 24 – 29 with a mean score of 27.0 for the ACT examination.

* In order to fulfill new federal government reporting requirements on race and ethnicity, students were given the opportunity to select multiple race categories. In addition, Pacific Islander was designated as its own category (separate from Asian). The students were asked two questions. The first question asked the student "Are you Hispanic/Latino?" The second question allowed students to select among five race categories, with multiple responses allowed.

In this report, two race/ethnic group tables are presented. In the first table, students are counted in only one race/ethnic group category. If the student indicated "yes" to the first question, the student was categorized as Hispanic (only) regardless of any race code(s) they may have selected. If the student marked more than one race (and "no" to Hispanic/Latino in the first question), he/she was reported in the category of Multiracial. The second table counts a student in every race/ethnic group category he/she selected. The percentages in this table are based on the headcount of students.
