ENTRY FEES

- FEE PAYMENTS:** **All regional academic and athletic entries and fees** should be sent to the Regional Executive Committee member who represents your district (see p. 3). The District Director will then see that a check for all fees in his or her district (excluding golf green fees) is received at Baylor University by **Friday, April 4** for both Academic contests & Athletic events.
- ONE-ACT PLAY ENTRY FEE:** Each One-Act Play that competes at the regional meet will be assessed a \$250 entry fee. Each member of the One-Act Play cast and staff will not be required to pay the general entry fee in addition to the One-Act Play entry fee.
- Schools with plays advancing from area to regional should send their One-Act Eligibility Notice and fee to **Susie Johnston, Regional Director at Baylor University, One Bear Place # 97101, Waco, TX 76798-7101** on the next school day following the results of the area competition. **FAX 254-710-4640. - Note: Spectator admission will be a **\$7.00** one-time-charge for any and all plays.
- L-D DEBATE FEES:** Lincoln-Douglas Debate contestants each must pay \$20.00 and a judge fee of \$50 is required per district.
- ACADEMIC FEES:** Each contestant is required to pay a \$15.00 per event fee. Team event fees are \$45.00
- The District Directors of each district will be assessed for a full slate of entries for the athletic and academic events. See above instructions for fees for One-Act Play.
- Schools are not required to send an entry form or fee to the regional site but will be assessed for their qualifiers by their District Director.
- GOLF FEES:** Each contestant is required to pay \$20.00 as an entry fee. This should be sent to the District Director for your district along with a list of your players. Additional \$25/day (total of \$75.00) green fees are to be paid at the golf pro shop. (See Golf Tournament Information, Page 20)
- TENNIS FEES:** Each contestant is required to pay \$20.00 as an entry fee. This should be sent to the District Director for your district along with a list of your players. (See Tennis Tournament Information, Page 23)
- TRACK & FIELD FEES:** Each contestant is required to pay \$15.00 as an entry fee. This should be sent to the District Director for your district along with a list of your team. (See Track & Field Information, Page 25)
- Note: Spectator admission is **\$5.00** for students and **\$8.00** for adults, each day.

ELIGIBILITY AND CERTIFICATION

ENTRIES: All academic entries, except One-Act Play are certified and entered into the Regional Meet through the UIL Spring Meet Online System. The District Meet Results form serves only as the official entry form for all athletic entries. Each District Director General is responsible for sending the athletic form to the regional site immediately following the district meet. **FAX to 254-710-4640.**

ELIGIBILITY: The eligibility of a student competing at the regional meet is the responsibility of the individual school. No form is required except for the One-Act Play.

ACADEMIC CONFLICTS: If a student who has followed the State Conflict Pattern (page 11) earns eligibility to compete at the regional level in more than one event and finds that he has a full or partial conflict in the two events, he must notify the regional director about the conflict five days prior to the meet. When possible, an adjustment will be considered.

LATENESS: A student will not be allowed to enter a contest room late without prior permission from the contest director. No exceptions are made in Calculator Applications and Number Sense. If a contestant needs to leave early to go to another event, these arrangements (where permitted in the contest plan) **MUST** be made with the contest director prior to the beginning of the contest.

WITHDRAWALS/ALTERNATES: If a regional contestant cannot attend the Regional Spring Meet, the contestant's principal or sponsor must notify the District Director of their district and request that he/she contact the alternate and the Regional Director.

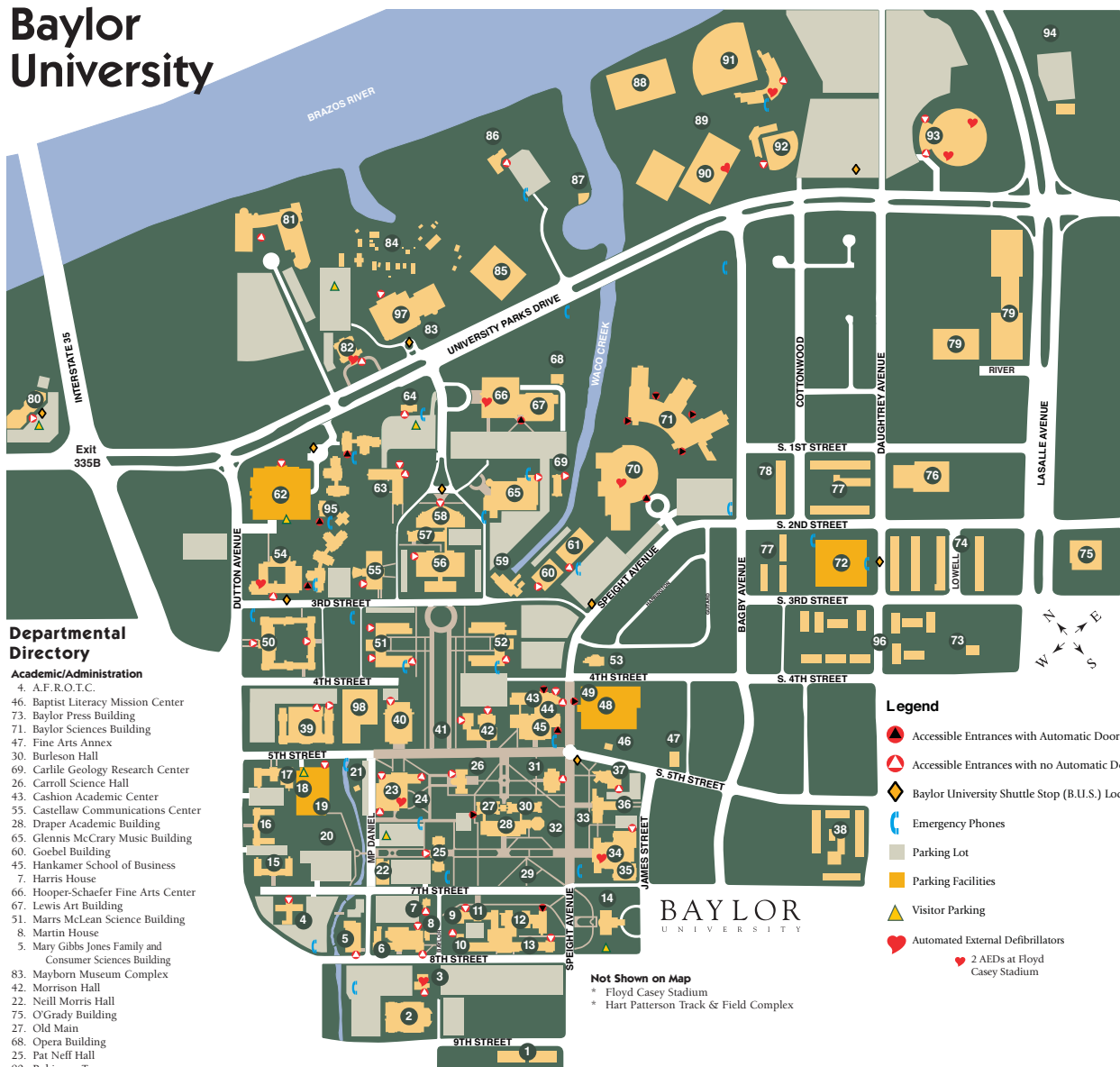
If a member of a school's **team** is unable to compete, only **one** substitution may be made. The substitute must give the contest director a letter or substitution form signed by a campus administrator to certify eligibility, unless his/her name already appears on the regional entry form. **If more than one member of a team is unable to compete, the alternate team will then advance to competition.**

Lincoln-Douglas Debate

If a school has a regional qualifier that cannot participate in the meet, the school is obligated to call the Regional Academic Director at (254) 710-6219. See the 2007-2008 UIL Constitution & Contest Rules, p. 106-107, Section 1002, (b) (3), (4), & (5) and the Official Notices of the "Leaguer."

VERIFICATION/AWARDS/WINNERS' PACKETS: Information regarding the 2008 UIL Academic State Meet is posted on the UIL website at www.uil.utexas.edu. Information packets will not be mailed to schools or handed out during the regional meet verification meetings or awards ceremonies, except for One-Act Play and L-D Debate. Coaches and contestants must go to the UIL website for the tentative schedule, UT parking, UT campus map and other vital State Meet information. **Responsibility for knowing times, dates, and sites of State Meet events rests solely with coaches and contestants.**

INSTRUCTIONS FOR DIRECTORS AND CONTESTANTS

1. **ORDER OF REHEARSALS AND PERFORMANCES:** The rehearsal schedule and performance order was determined through a random drawing by the Contest Director and Regional Director.
2. **TECHNICAL ASSISTANCE:** The Department of Theatre Arts will host OAP and will provide technical assistance during the contest. Your company will be responsible for loading in, setting up scenery and properties, striking scenery and properties and loading out. The Department of Theatre Arts will provide crews to operate the light and sound boards but competing schools should provide an advisor for each technical activity and a written list of light and sound cues. It is highly recommended that a designated leader or stage manager should also be provided by the competing schools.
3. **LOADING AND UNLOADING:** Plan to unload 1/2 hour before scheduled rehearsal times. You will be met by a Theatre Arts assistant. The loading door is located at the rear of the Fine Arts Center by the loading dock. Your company must load as soon as your performance is over. Trucks must be moved as soon as loading or unloading is complete.

6. **SCENERY:** UIL unit set **will** be available at the contest site. Set pieces provided by your school must be approved by the UIL State Office.

7. **PROPERTIES:** All properties will be supplied by the OAP participants. The Department of Theatre Arts will not supply any stage or hand properties. Limited storage space will be provided for each school.

8. **LIGHTS:** Lights will be pre-set to give sixteen acting areas. (See floor plan on page 9). No specials will be provided but the areas can be varied by intensity or blackout. A lighting technician will be available to run the board assisted by your operator. The light board is located in the booth at the back of the auditorium, not backstage. The booth, however, is considered backstage. Anyone other than the three designated crew members entering the booth could be grounds for disqualification. Please provide a light cue list for the lighting technician.

9. **SOUND:** A sound technician will be available to run the equipment assisted by your operator. The sound equipment is located in the booth. There is a CD player available as well as a cassette player that will play through the house system.

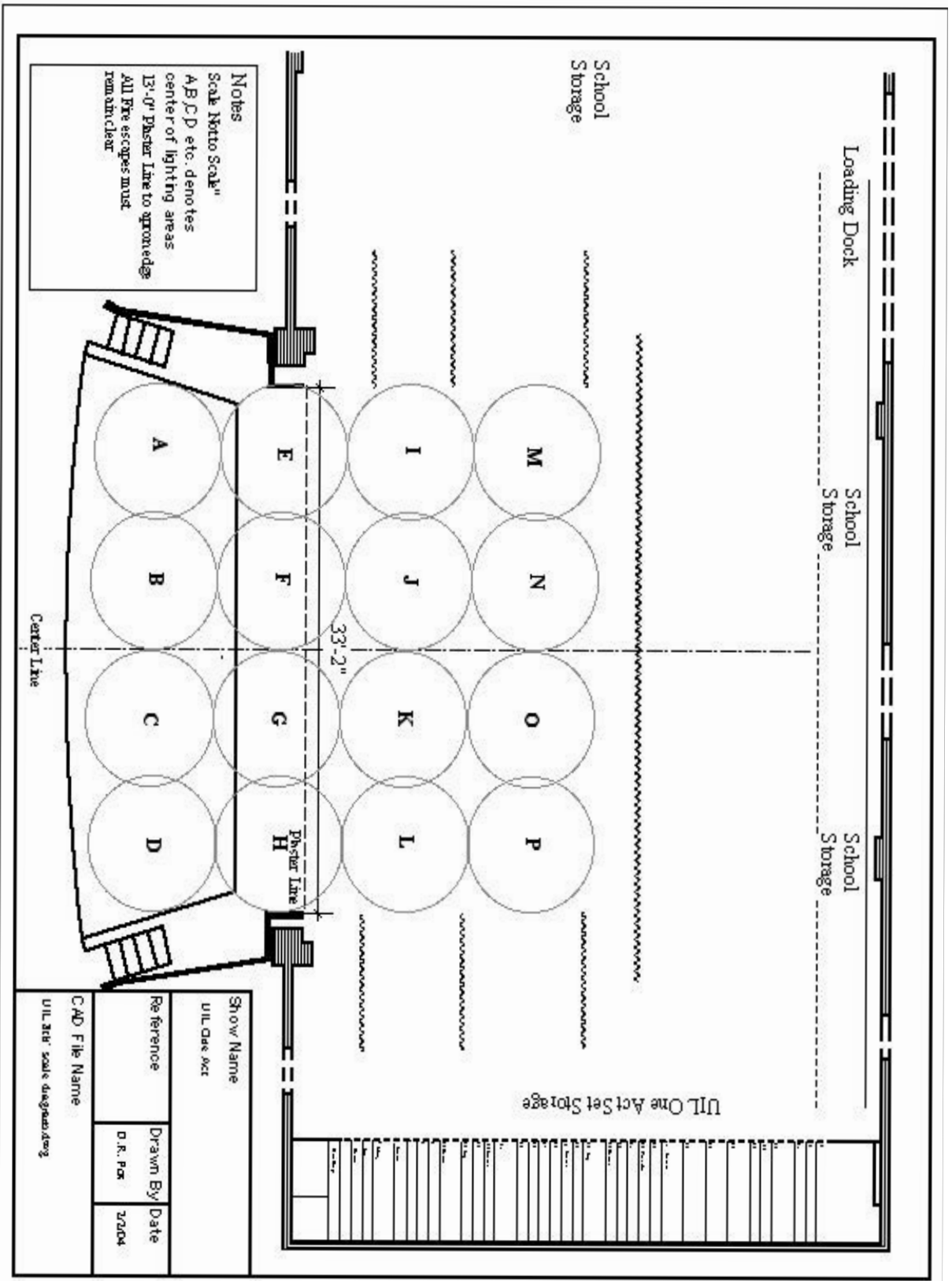
10. **AWARDS AND CRITIQUES:** The awards presentation will take place in the theatre as soon as the judge has made final decisions. All schools are expected to participate in the critique sessions immediately following the award ceremony.

11. **HOUSE POLICY:** **Admission** will be a **\$7.00** one-time-charge for any or all plays. No charge for Director, Assistant Director, cast, crew and alternates. **Absolutely no one may enter the house during a performance.**

- A. Be on time. Lost time cannot be made up.
- B. Please be quiet when in the general theatre area. Sound travels very easily in the facility.
- C. No smoking, eating or drinking is permitted in any of the theatre facilities.
- D. Please keep the dressing rooms clean.
- E. You will be responsible for the personal property of your company.
- F. Please attend as many performances as possible. Your support is always appreciated.

SET-UP	PRELIMS	FINALS

The conflict pattern is not mandated, but it will be honored at all regional meets. Districts are also urged to use the conflicts in setting a schedule for their meets. Regional schedules will not be modified to allow participation in conflicting events.

- SESSION I (3 hours)** The following events may begin at the same time: prose, poetry, L-D debate, ready writing, computer applications and current issues & events. Calculator applications, number sense and computer applications may not be held at the same time. Students may also participate in both current issues & events and computer applications at district so long as they are set up and do not delay the start of the computer applications contest. CI&E and Computer Applications conflict at region and State. Number sense conflicts with current issues & events, ready writing and prose/poetry interpretation.
- SESSION II (2.5 hours)** The following events may begin at the same time: informative speaking, persuasive speaking, spelling & vocabulary, literary criticism, science and accounting. News writing and feature writing may not be held at the same time. Note: persuasive speaking finals and computer science programming may conflict.
- SESSION III (2 hours)** The following events may be held at the same time: mathematics, social studies, prose, poetry and L-D debate. Editorial writing and headline writing may not be held at the same time. Computer science and mathematics may not be held at the same time.

3. Shot put and discus circles are concrete, so plan for appropriate foot wear. The shot put area does not meet UIL and High School Federation standards. The throwing sector will be limited by collegiate facilities.
4. Implements should be marked with the school name. They should be turned into the appropriate official at the implement check-in area no later than the designated time:
 - SHOT PUT Boys: Friday 7:30 - 8:30 am
 Girls: Friday 7:30 - 8:30 am
 - DISCUS Boys: Friday 7:30 - 11:00am ; Saturday 7:00 - 8:00 am

5. Throwing event preliminaries will **not** throw in groups of two (2) – five (5) as Rule 6.2.5 suggests. Rather all eight (8) competitors listed in each flight will throw together.

7. Running events check-in is 30 minutes prior to event. Athletes will **not** be permitted on the in-field prior to this time. Hip numbers and bib numbers must be visible.
8. The athletes' warm-up area is located at the southeast corner of the track complex. General warm-up will **not** be permitted in the track in-field area. Athletes may only access the infield through the gate located at the pre-check-in area.

11. **Entrance gate:** All officials, coaches, and trainers will enter and exit the complex from the southeast corner gate. A sign will mark the entrance. Wear badge or number.
12. Trainers may set up training tables behind the bleachers on the parking lot side of the Track Complex. Baylor trainers will be on site to assist teams. Please contact the Baylor trainers if EMS assistance is needed.
13. Tents will not be permitted in the spectator areas (e.g., bleacher areas).
14. Please note that the 3200 meter run, both boys & girls, has been placed late in the order of events and will be run as a final from a "waterfall start." The same treatment applies for the 1600 meter run, which will be Saturday; as a final with a waterfall start.
