CLASS NEWS

<u>CLASS OF1932</u> *FLORENCE P KENDALL*, PT, FAPTA, 95, died on Saturday night, January 28. The following was written about Florence on the APTA website following her death:

She dedicated more than 70 years of her life to physical therapy, continuing to be one of this country's foremost physical therapists well into her 90s. As recently as last year, she received the 2005 Charles M Magistro Distinguished Service Award from the Foundation for Physical Therapy for her outstanding service and personal commitment to promoting the goals of the Foundation.

She played a major role in drafting the original bill that was enacted into law in 1947 legally establishing the practice of physical therapy in Maryland. She was the secretary to the Maryland State Board of Physical Therapy Examiners from 1969-70, a member of that Board from 1971-74, and served as a consultant to the Board from 1974-97. Kendall and her husband, Henry, spent many years treating patients with polio at Children's Hospital as well as in their private physical therapy practice.

She taught physical therapy at the University of Maryland's School of Medicine, Physical Therapy Department. She was also an instructor in biomechanics at the School of Nursing at Johns Hopkins Hospital. A nationally acclaimed lecturer and author of numerous books and journal articles about physical therapy, Florence Kendall's work has set the standard for musculoskeletal evaluation and treatment.

Her book, Muscle Testing and Function, originally published in 1949, published its fifth edition last year. Recognized as the "gold standard" for musculoskeletal assessment, this work has been translated into eight foreign languages.

Kendall is a founding member of the American Physical Therapy Association of Maryland and was its president 1939-41 and 1957-59. She served on the Maryland State Board of Physical Therapy Examiners and also was a consultant to the Surgeon General of the United States Army.

Kendall's work as a clinician, researcher, and lecturers earned her many awards and honorary degrees. In 1976, the Maryland Chapter established the Henry O Kendall and Florence P Kendall Practice Award for outstanding achievement in clinical practice; in 1980 it became a national honor from the Foundation for Physical Therapy. In April 2000, the Kendall Historical Collection of books at the University of Maryland Health and Human Services Library was dedicated. The Henry O and Florence P Kendall Conference Room was dedicated at the University of Maryland's School of Physical Therapy in December 2000. She was named to the Maryland Women's Hall of Fame in 2002.

A McMillan Lecturer, Catherine Worthingham Fellow, and recipient of the Lucy Blair Service award, among many other honors, Kendall was a role model for all physical therapists, but especially to women. She clearly demonstrated that a woman can be a good wife and mother, and at the same time be a leader in her chosen profession. <u>CLASS OF 1946</u> LAURA COLEMAN: Wrote I want to report in and thank you for your effort to keep tract of "us". I appreciate Major Vogel for the effort she put forth to teach our ten. To someone's credit I have done well to be a professional who has been helpful to a community for over 60 years. Her picture hangs in our home and one thing she said everyday "when I say one o'clock I don't mean a minute over or a minute under:" Our four children were helped by this too. I thank you again and what a wonderful profession we have.

<u>CLASS OF 1941</u> JACQUELINE PERRY: Attended the Alumni Association Reunion activities in San Antonio last year and received the Distinguished Alumni Award.

<u>CLASS OF 1946</u> RACHEL ADAMS: Reports she and Marilyn Anderson (1951) visited Knollwood in Washington, D.C. where we had a lovely lunch with Barbara Friz. Barbara, at 96, was as vivacious as we remembered her. In a recent letter to me she states "I'm still in the Health Center and traveling mostly in a wheel chair, but hope to use a walker most of the time soon. I go to PT almost every day and that always makes me feel better. Incidentally, they allow me to be my own PT instructor." While at Knollwood, we also had a lovely chat with Agnes Brigham (1945) and visited Liz Davies briefly.

CLASS OF 1946 GENEVA JOHNSON: The number of us who came before 1949 grows smaller every year. Some old soldiers just fade away and some of us do not know how to do that. In 2000 my husband and I moved to Baton Rouge. This year we escaped the vengeance of Mother Nature which left New Orleans in ruins. That has canceled plans for cruises from the Port of New Orleans until much further notice. Meanwhile, we are not idle. In 2002 I activated a long dormant plan to start a publishing business. By August, 2003 we had the first book in print, Taxonomy of Physical Therapist Behaviors. A companion to that one, Taxonomy of Physical Therapist Assistant Behaviors will be at the printer's and bindery this week. In between we published Educating Physical Therapists as Primary Care Practitioners: Competencies for the Learner and Faculty Development. More are on the way. I have been the primary author for the two Taxonomies and contributed a chapter to the one on primary care practitioners. My real work has been editing and organizing every thing for the final copy, deciding on the covers, and then handling the sales. We have published a beautiful volume for a landscape architect that he titled: A Philosophy of Planting, and two whimsical art books--Dainty Dragon and Baby's Day. A Philosophy of Planting will be issued in paper back within the year. Clearly this is not a business that makes any money but does keep me occupied. I have learned enough about the computer to manage but not enough to be self-sufficient so have a consultant who helps me not to panic when all seems to go wrong. My interest in physical therapy has never waned for which I am grateful and feel blessed to have been a part of the changes over the past 60 years--and more to come, I hope.

<u>CLASS OF 1951</u> MARYILYN (ANDY) ANDERSON: This past year has been busy with some travel and lots of volunteer work. A couple of trips to Canada and two weeks in England skippering a "narrow boat" through the midlands canals were the highlights for travel. We also had lots of visitors, among them Jane Sweeney, Alice Harmon Bageant (and husband Bob), and Chris Standley Brazell from the class of 1968. Jane also popped into the hospital in Bellingham to help us get Rachel discharged after an ankle fusion. What an eye-opener in process to those of us who haven't seen much of hospitals since being on active duty! This coming July we are planning to accompany the local Orcas A Capella Choir to Mainz, Germany with a three-day stopover in Prague. The highlight in Prague (and probably the entire trip) will be seeing Phyllis Plotnick from the class of 1970.

<u>CLASS OF 1952 #4</u> H. JO McKINLEY: I moved into Exeter House, a retirement home in downtown Seattle, prior to having abdominal surgery for colon cancer in March 2005. Am doing OK and plan to move into a larger apartment with a great view soon.
