Volumes 1&2 provide information on private and public companies arranged alphabetically.

Volume 3 provides a geographic listing of companies. This volume also contains a special features section which list the 1,000 largest publicly held companies, the 1,000 largest privately held companies, the 1,000 largest employers, an analysis of public and private companies by state, analysis by revenue per employee of the top 1,000 companies, and analysis of private and public companies by 4-digit SIC.

Volume 4 arranges companies according to their 4-digit SIC code and ranks them by their sales volume which allows the reader to determine an approximate market share.

Business & Company Resource Center

Formerly General BusinessFile ASAP, this resource brings together in a single database company profiles, company brand information, rankings, investment reports, company histories, chronologies, and periodicals.

Business Source Complete

Indexes scholarly business journals covering management, economics, finance, accounting, international business, and much more. About 80% of the journals are available with full text.

D&B Key Business Ratios

Provides selected industry ratios in three major areas: solvency, efficiency, and profitability. Users can search by various means, including SIC code, line of business, asset range, and year. Data can be exported to a spreadsheet for further analysis. Includes the latest three years for which data are available.

Lexis/Nexis Academic

The business component of Lexis-Nexis Academic UNIVerse includes company, country, financial, demographic, market research and industry reports. Approximately 120,000 new articles are added each day from worldwide newspapers, magazines, news wires and trade journals.
