REUNITING FAMILIES

In February we will meet in the new science building for an opportunity to learn about a compelling problem and a fascinating project. Round Table member Dr. Lori Baker of Baylor's Forensic Science program will share with us her current project, "Reuniting Families." Dr. Baker is working to set up a DNA bank for identification of illegal immigrants who die attempting to enter the United States from Mexico. An estimated three hundred people including women and children die each year in an attempted crossing. About a third of these are never identified and their families are left with no answers about their fate. Current systems are falling woefully short in addressing this need. To quote Lori, "Something had to be done." Come hear what is being done and how Baylor professors are leading the charge.
