I. Texas State Senate Files, 1932-1936, 4 linear feet, Box 1-8

The State Senate Files series consists of two linear feet of printed material and correspondence covering a portion of Poage's career as a state senator from 1933-1937. Poage served in the state house from 1925-1929, and he served in the senate from 1931-37. Also included within the series is printed material and correspondence from Poage's unsuccessful run for Congress in 1934 against then Congressman O. H. Cross. Materials from Poage's 1936 congressional effort are also present.

These files concerned with Poage's state senate activities primarily contain correspondence concerning appointments, job applications for state positions, and political matters within the 13th State Senate district (McLennan, Falls, Milam, and Limestone counties). Among other items within the files are legislative files involving bills on a wide range of topics, including state responses to early New Deal programs. State level topics dealt with in the files include horse racing, alcohol taxation, and the regulation of chain stores.
