#### **Open Records Workshop**

On Tuesday, June 8, Chris LaPlante and two others from his staff at the Texas State Archives held a workshop in the Bullock Exhibit Area relating the Texas Open Records Act to the Bullock papers. Representatives from Texas Tech, UT Austin, Texas A&M Laredo, Blinn College, and Hill College met at Baylor for the workshop. The staff revealed the difficulty descending upon us all if someone requests to see the Bullock papers or microfilm. Requests for information that may contain private information cannot be released to a researcher. If they insist, an open records request must be filed with the Texas Attorney General's office. Copies of the requested items must be submitted along with a legal brief within ten days of the request. Failure to do so in a timely manner automatically makes the requested information available to the researcher. Because of the way Bullock's staff filed correspondence, private information could be contained in Therefore, archival staff must preview every document in every file before releasing them to researchers.



The logistics of this may require institutions with inadequate staff to relinquish their records to the state archives. Unfortunately, Baylor does not have this option. Fortunately, as a private institution, Baylor is not legally subject to the Texas Public Information Act. Baylor lawyers have been in contact with the state archives working out a contract whereby we can make open records requests directly to the attorney general's office. Because this is pending, it is uncertain what we will do if a researcher appears after July 12 but before the contract is signed. We plan a visit to the state archives some time in July to see how the process of requesting an open records ruling works. Hopefully, a Baylor lawyer will be able to go with us.

#### RESEARCHERS
