Failure to complete community service and the paper by the deadline will result in suspension for the spring 2010 semester.

<u>Alleged Violation</u>: Misrepresented facts to obtain an academic or economic advantage.

Date of Violation: 06/29/2009

**<u>Decision</u>:** Guilty <u>Sanction</u>: Received a permanent F in the course, immediate expulsion from Baylor, and transcript stamped with notation that student was expelled for an Honor Code violation.
