ABAA Pursues Affiliation with BU Main Campus

The biggest reason for delaying our Winter newsletter was our collaboration with BU for potential alignment. BU approached us in December 2012 to align our ABAA under the main campus for numerous jointly-beneficial reasons including: ensuring a common theme and message to BU Alumni; fostering increased public awareness of ABAA activities and ongoing initiatives (research, scholarships, etc.); fullspectrum no-cost administrative, legal, marketing, finance and IM-IT/ webpage support; and full 501(c)3 tax-free benefits for our organization and our donors. Once affiliated with BU, we will not be required to pay federal/state corporate income tax, and our donors will be able to deduct donations to the ABAA as a charitable donation. This may open up a significantly deeper pool of benefactors, especially if we are eventually added to the Combined Federal Campaign (CFC) roster, which would certainly raise the public status of the Army-Baylor Program and positively affect our future U.S. News and World Report ranking. Another HUGE benefit with BU collaboration is that we would not have to hire a full time administrative person to handle being a 501(c)3 organization.

If affiliated with BU Main Campus, ABAA website would be located on the Baylor Alumni Network website (<u>http://www.baylor.edu/network/</u>). We would be one of the groups under 'Networks' like 'Business' and 'Women'.

That said, there may be some drawbacks to affiliation including: a possible name change to the Army-Baylor Alumni Network (or similar title that will not confuse us with the BU Alumni Association) and possible joining of bank accounts (although we'll retain control of our account and donors can ID us specifically for donations). We would also have to ensure all funds are distributed to events or initiatives that are in keeping with the high standards and traditions of both BU and Army-Baylor, which is already a key component of our ethics model.

COL Novakoski writes, "In October 2012 while deployed in Kandahar, Afghanistan as DCCS of 10th Combat Support Hospital (CSH), I received an email from III Corps (Fort Hood) Public Affairs Office. The email stated that Baylor President Kenneth Starr had invited LTG Don Campbell (Kansas State alumni) to the Baylor vs K-State football game on 17 November 2012. The PAO also stated that I, as the senior Baylor alumnus at Fort Hood was also invited to be Judge Starr's guest in the President's Skybox for the football game.

Fortunately, this game occurred about 2 weeks after I re-deployed so I was able to attend. As a Baylor alum, Judge Starr asked me to run onto the field with him in front of the Baylor Freshman Line students at the beginning of the game. Hello, Baylor Bears!

I am sending this update from San Antonio and Fort Sam Houston as we are enjoying our normally warm South Texas winter following a great holiday season and after being thrilled with another winning Baylor Bear football season! Additionally, I have the pleasure of reporting that 100 students were enrolled in our program this year(45 members in the Class of 2013, 55 members in the Class of 2014) with prospects of the Class of 2015 having nearly 60 students .

We have outstanding news of student achievement over the past few months:

A group of students representing each of the military services, DAC, and VHA developed a jointly-authored paper, "Analysis of San Antonio Military Medical Center ER\Trauma CT Scanner", within CAPT Tom Mihara's Operations Management Course that achieved "Best Student Research Paper" standing for 2011 – 2012 from the American Academy of Medical Administrators (AAMA). Additionally, Army-Baylor alum and former faculty member, LTC (RET) Chris Pate, Ph.D. provided mentoring support for the student group. Group members included: Ms. Kenya Brown (VHA), Ms. Stefanie Harris (DAC), CPT Sean Hoskins (USA), LT Jose PonceVega (USN), and CAPT Barry Warshaw (USAF).

Another group of students and faculty were recognized by the National Academy of Healthcare Quality for earning the annual "high impact" award for an article published in the Journal of Healthcare Quality. LT Chad Smith, LCDR Suzanne Wood, Ph.D., and LTC Brad Beauvais, Ph.D. jointly developed the paper, "Thinking Lean: Implementing DMAIC Methods to Improve Efficiency within a Cystic Fibrosis Clinic.

The annual summer transitions brought three new teammates and their families to the Army-Baylor program: MAJ Fred Weigel recently completed doctoral studies in management at Auburn University and completed a year of service as Chief, IMD at Eisenhower Army Medical Center before arriving to replace MAJ Mark Mellott in conjunction with Mark's deployment to Afghanistan. Major (CH) Thomas Brooks arrived for faculty service having completed graduate studies in Medical Ethics at Trinity Graduate School. Finally, Army-Baylor alumnus, Major Mishaw Cuyler arrived as a doctoral candidate from the School of Business at the University of Texas-El Paso. Page 12

CONSTITUTION OF THE ARMY BAYLOR UNIVERSITY ALUMNI ASSOCIATION

ARTICLE I - NAME

The name of this organization shall be the Army-Baylor Alumni Association, hereafter referred to as the "Association" herein.

ARTICLE II - OBJECTIVES

The objectives of the Association shall be:

a. To foster, maintain and strengthen a sense of fraternity among alumni of the Army-Baylor University Graduate Program in Health and Business Administration (hereafter referred to as the "Army-Baylor Program");

b. To promote Association affiliation to all alumni;

c. To enhance communication among Association members;

d. To promote education and professionalism of the program and in the field of health care administration;

e. To encourage membership and participation in professional health care management organizations;

f. To arrange and conduct social events for Association members;

g. To provide advice and support to the faculty and staff of the Army-Baylor Program in order to promote and enhance the quality of the program for future graduates;

h. To provide legally-permissible financial support to the Army-Baylor Program in coordination with the Program Director

i. To recognize alumni and current Army-Baylor Program students for noteworthy service and contributions to military and civilian health care administration.

ARTICLE III - MEMBERSHIP

- a. Membership in the Association shall be voluntary.
- b. Membership shall encompass the following categories:
 - (1) Active: Any alumnus or Residents whose dues are current.

(2) Honorary: A non-alumnus who has significantly contributed to the Army-Baylor Program or the field of military health care administration and who has been nominated by the active membership and elected by the voting members of the Executive and/or Awards Committee.

ARTICLE IV - OFFICERS

a. Association officers shall be active Association members and shall collectively constitute the Executive Committee.

b. Association officers with voting privileges shall be the following:

- (1) Past President;
- (2) President;
- (3) President Elect/1st Vice President;

(4) 2nd Vice President;

(5) Secretary/3rd Vice President

c. Appointed Association officers without voting privileges shall be the follow-ing:

(1) Treasurer;

(2) Director, U.S. Army-Baylor University Graduate Program in Health and Business Administration;

(3) Army Regent, American College of Healthcare Executives;

(4) Information Technology – website administrator.

d. The manner of election/appointment of officers shall be in accordance with the Association Bylaws.

Bylaws.

(1) At least one of the voting officers shall be a retired/civilian Alumnus.

(2) If at the time of the annual election of the 3rd Vice President all voting officers are retired/civilian alumni, only active duty alumni may be nominated for 3rd Vice President. In that way, at least one of the voting officers shall be serving on active duty.

e. Duties:

(1) The Past President shall serve as principal advisor to the President and shall perform those tasks as requested by the President.

(2) The President shall:

(a) Direct the activities of other officers of the Association;

(b) Serve as principal liaison between the Association and the Baylor University Alumni Association;

(c) Chair all Association committees;

(d) Serve as an advisor to the Army Regents of the American College of Healthcare Executives on matters of concern to Association members;

(e) Approve the disbursement of funds.

(3) The President Elect/1st Vice President shall:

(a) Serve as principal assistant to the President;

(b) Revise and staff amendments to the Association Constitution and Bylaws;

(c) Organize and conduct marketing and fund-raising activities.

(4) The 2nd Vice President shall:

(a) Arrange the annual alumni dinner in conjunction with the American College of Healthcare Executives Congress on Administration and prepare publicity for the Association newsletter;

(b) Serve as Co-Chair of awards committee and administer awards functions, to include dissemination of publicity and criteria for each award (Distinguished and Honorary Alumni) receipt of nominations, dissemination of nominations to Awards Committee members, and counting of votes.

(5) The Secretary/3rd Vice President shall:

(a) Prepare the Association newsletter as stated in the Association Bylaws and submit it to the Baylor University Alumni Association for publication and distribution;

(b) Prepare the agenda for the annual business meeting;

(c) Prepare Executive Committee meeting minutes.

(6) The Treasurer shall:

(a) Maintain accounting records in accordance with applicable rules and regulations;

(b) Prepare a fiscal year financial statement for distribution at the annual business meeting; (c) Serve as liaison with the Baylor University Alumni Association on all matters regarding dispersal of Association funds on deposit with the University Alumni Association;

- (d) Purchase awards for presentation at the annual alumni dinner;
- (e) Prepare a proposed budget for the upcoming fiscal year.

ARTICLE V - MEETINGS

a. The Executive Committee shall meet at least annually, normally in conjunction with the American College of Healthcare Executives Congress on Administration. Minutes shall be maintained. The agenda will encompass, at a minimum, the following:

- (1) Financial report;
- (2) Membership review;
- (3) Proposed budget for the upcoming year;
- (4) Awards to be presented at the alumni dinner;
- (5) Suggestions for future Association activities.

b. A general membership business meeting shall be held annually, normally in conjunction with the American College of Healthcare Executives Congress on Administration.

(1) For the purpose of conducting business, a quorum of members must be present. A quorum is defined as a minimum of sixteen active members in good standing.

(2) The information discussed at the Executive committee meeting shall be disseminated to the membership with the exception of names of awards winners which shall be announced at the alumni dinner.

c. An alumni dinner shall be held annually in conjunction with the American College of Healthcare Executive Congress on Administration. The dinner will normally be scheduled for Tuesday evening of Congress week.

ARTICLE VI - DUES AND OTHER SOURCES OF INCOME

- a. Annual Association dues shall be recommended by the Executive Committee and approved by majority vote of the members present at the general membership meeting.
- b. Dues structure shall be in accordance with the bylaws of the Association.

c. Honorary members shall be exempt from payment of dues.

However, if these individuals choose to pay dues, they will be granted all privileges accorded active members.

- d. Monetary contributions for either general or specific purposes may be accepted. Contributions, which pose a possible conflict of interest for government employees, will be reported for legal review prior to final acceptance by the Executive Committee.
- e. Any other income-producing activities shall be approved by the Executive Committee.

ARTICLE VII - DISSOLUTION

Upon discontinuance or dissolution of the Association, all of its assets shall be liquidated and the proceeds thereof applied to purposes in consonance with the stated objectives of the Association. Distribution of proceeds will be approved by the Executive Committee.

ARTICLE VIII - ADOPTION AND AMENDMENT

The constitution and bylaws shall be adopted and amended in accordance with the bylaws of the Association.

Charles Benninger Named 2012 Healthcare Executive of the Year by the American Academy of Medical Administrators

Des Plaines, IL, December 3, 2012 - Charles O. Benninger, CFAAMA, Utilization Management Coordinator, Illiana Veterans Healthcare System in Danville, Illinios, was named the 2012 Healthcare Executive of the Year by the American Academy of Medical Administrators (AAMA). Benninger received the award during the 2012 AAMA Annual Conference in San Antonio, TX, on November 14, 2012. The Healthcare Executive of the Year Award is the Academy's highest honor. It recognizes an individual whose work has provided an environment for delivering the maximum level of quality care with dignity and human concern.

Benninger successfully completed a 25-year naval career, which included service as a hospital corpsman and Nurse Corps Officer. While serving as the executive officer at the Naval Hospital in Jacksonville, Florida, Benninger implemented sweeping organizational changes. These included the introduction of Relative Value Units productivity standards, a performance based budget model and the development of an organizational report card for utilization in decision-making by the Board of Directors. During just two months, as a director in a private multispecialty practice, Benninger directed the acquisition, implementation and conversion to PACS and CR imaging systems at four clinic locations. In his current position with the Illiana Veterans Healthcare System, he provided guidance in the successful implementation of an interdisciplinary process for the inpatient care unit that has cut avoidable bed days in half and resulted in cost avoidance of over \$1.5 million.
