Research Ramps Up

August 25, 2010 - Waco

Over the past academic year the research efforts within the Sport Management program have expanded with the addition of new program director, Dr. Jeffrey Petersen. The dissemination of new knowledge in the Sport Management field has become a program priority, and both the faculty and students are becoming actively engaged in the process. This includes numerous presentations and publications by both faculty and students.

A total of 19 sport management related research presentations were made in the 2009-10 academic year at state (2), national (11), and international (6) conferences. Two student research groups made research presentations at the College Sports Research Institute (CSRI) Scholarly Conference on College Sport in Chapel Hill, NC. Morgan Mercer and Jon Weed presented *An Analysis of College Choice Factors by Freshman Student-Athletes Across All Sports,* and Erik Bengtson and Kyle McClure presented their research titled *Building Campus Community via Collegiate Football: The Impact of Campus Residence Status on Game Attendance.* A summary of the scholarly presentations for the year can be found on page 5.

Publications were another area of productive research this year within our program including 7 articles in peer reviewed journals, 4 published abstracts, 4 conference proceedings, 2 book chapters, and 1 invited journal publication. Leeann Lower was distinguished as the first program student to lead author a JOPERD Law Review article titled *Stadium Accommodations and JumboTrons*. Students Honored at National Case Study Competition in North Carolina

April 23, 2010 - Chapel Hill, NC

A team of four graduate students from the Baylor University Graduate Sport Management Program took home runner-up honors in the second annual Case Study Competition held during the "Scholarly Conference on College Sport". The event was hosted from April 21-23, 2010 at the William and Ida Friday Center at the University of North Carolina at Chapel Hill and sponsored by the College Sport Research Institute (CSRI). Team members Erik Bengtson, Leeann Lower, Kyle McClure and Morgan Mercer were honored for this accomplishment at the 2010 Scholarly Conference on College Sport Awards Breakfast that also featured a keynote address from Mr. Craig Thompson the Mountain West Conference Commissioner.

The Baylor team competed in a two-round case competition, and advanced to the finals by posting the top score in the opening round. The opening round focused upon a comprehensive feasibility analysis of a final effort to avert a move to Division III and remain in Division I by the University of New Orleans. The opening round included a 10 day period to develop a 1000 written response to the case along with a group presentation made before a panel of three judges (view the paper). In the second-round finals of the competition the Baylor team faced Georgia State University and Ball State University in the development of final recommendations and rationales for an action plan to avert the Division III reclassification. With less than 12 hours to prepare for the final group presentation the Baylor team focused its efforts upon the pursuit of an NCAA waiver extension and a move to the Southland Conference. The Bear's team easily surpassed the Panthers of Georgia State but was narrowly clipped by the defending champion Ball State Cardinals.

According to the team's faculty sponsor, Dr. Jeffrey Petersen, this case study competition was an outstanding learning experience where the academic training of our students was able to be showcased in an integrated problem solving and presentation experience within an intense environment. As the first foray by members the Baylor Sport Management Program into this type of competition, the results are an encouraging sign of great things to come for these students and for the program. Team member Kyle McClure commented, "While I was disappointed about the final outcome, it was a great learning experience and feel that it will be a great help in my future." Lee Lower, team captain, added, "The opportunity to combine our competitive nature with academic pursuit was exhilarating. The competition developed a unique motivation to push the boundaries of our research skills to wow the judges." Morgan Mercer noted, "The team passionately pursued optimal solutions to the case even after the final results were announced. We all were initially disappointed but we drowned our sorrows in creating even more solutions to the case." Erik Bengtson concluded, "It felt good to establish a strong tradition of success for Baylor's future in this competition, and with an elite eight and a final four it was great to make the top two this year."

Sport Management Faculty Roles

Over the past year several new faculty members have joined in the efforts to effectively deliver the curriculum of the Baylor sport management program.

- *Dr. Jeffrey Petersen (Ph.D. University of New Mexico)* joined the faculty in the fall of 2009. He has assumed the role of directing the Sport Management graduate program as well as serving as the coordinator of graduate admissions for the HHPR department. His current teaching in the program includes: HP 5336 Sport Marketing, HP 5372 Legal Issues, HP 4373 Sport Management, and HP 5398 Contemporary Ethical Issues in Sport. Dr. Petersen's background in teaching, coaching and interscholastic athletic administration, is combined with his 10 plus years of collegiate teaching, research and professional service.
- Dr. Kim Scott (Ph.D. Texas A & M) currently serves as the Director of Campus
 Recreation at Baylor, and in 2009 began teaching in the Sport Management
 program by taking leadership the HP 5376 Facility and Event Management
 course. Her extensive experience in recreational leadership and with the facility
 construction processes provides foundational background for her teaching.
- Dr. Andy Meyer (Ph. D. University of Illinois) began teaching in the program in the fall of 2010 within his specialty area of Sport Sociology by teaching the HP 5374 Sport in the Social Context course. He is currently researching and writing in the area of Muscular Christianity in contemporary American sport.
- Mr. Kevin Tankersley (M.A. Arkansas-Little Rock) teaches full time in the
 Department of Journalism, and has stepped in to serve as the instructor for HP
 5338 Public Relations in Sport. His tremendous work experience in sports
 writing and in the collegiate Sports Information Director role provides an
 excellent foundation for his work in the program.
- Dr. Glenn Miller (Ph.D. University of New Mexico) continues to serve as the
 coordinator of internships for the entire HHPR graduate program. Dr. Miller
 also teaches the HP 5377 Issues and Trends in HP and Sport Management. Dr.
 Miller's primary duties lie in the direction of the Sport Pedagogy graduate
 program and in serving as the director of the HHPR graduate programs.
- Dr. Andy Pittman (Ph.D. Texas A & M) entered into a well deserved retirement
 after founding and leading the program for many years. Pittman joined the
 Baylor Faculty in 1985, and he concluded his teaching at Baylor during the
 summer of 2009. Dr. Pittman now resides in Puerto Aventuras, Mexico. He
 continues to provide input and guidance to the program through regular
 contact from the beach back here to the BU campus.
