



#### **Livingston New Director of Executive MBA Program** in Dallas

Kate Livingston has been named as the new director of the Executive MBA program in Dallas for Baylor University's Hankamer School of Business. Livingston comes to Baylor from the University of New Mexico, where she was associate dean for Executive Education and Community Outreach, serving on the executive leadership team for the Anderson Schools of Management.

#### Hankamer **Maintains 38th Spot** in BusinessWeek Rankings

The Hankamer School of Business maintained its rank at 38th in BusinessWeek's rankings of the Top 50 Undergraduate Business Schools, earning a grade of A in teaching quality, facilities and services, and job placement. In the specialty rankings, the School ranks 3rd in Ethics, 10th in Business Law and 26th in Accounting.

"Even with 39 new schools joining the rankings this year, and nine of them entering the top 50, we held our spot," said Terry Maness, dean. "We earned the second-highest ranking within the Big 12 and the third-highest ranking in the Southwestern United States."

### **New Research Centers** in Real Estate Selling and Nonprofit Studies

Baylor University Regents approved the creation of two new research centers in the Hankamer School of Business. The new centers are The Keller Center and the Center for Nonprofit Studies.

"The Keller Center will provide innovative research related to real estate buyers and sellers that will be of immediate benefit to stakeholders in the real estate industry," said Dr. Terry S. Maness, dean of Baylor's Hankamer School of Business.

The Center for Nonprofit Studies will contribute to the effectiveness of nonprofit organizations by focusing research efforts on critical problems facing the nonprofit community, providing undergraduates with course sequences that can be added as minors to both business and non-business majors, and offering nonprofit managers access to best practices among such organizations.

#### New Course in **Forensic Economics Teaches Students How** to Assess Damages in Litigation

Beginning this semester, Baylor University's Hankamer School of Business will be the only school in Texas offering a class in Forensic Economics. In fact, only a handful of universities in the entire United States offer a comparable course.

# **Investment Fund Contributes** \$210,000 To Scholarships

For the fourth straight year, the Baylor University Athletic Department will receive a generous financial contribution from the Philip M. Dorr Alumni & Friends Endowed Investment Fund. After being presented with gifts from the fund totaling \$450,000 over the past three years, a \$210,000 donation from the fund was given to the department this spring.
