Tools for Locating Primary Sources

Electronic Resources (at the Libraries' "Electronic Resources Directory": http://www1.baylor.edu/ERD/Search/Search.aspx)

<u>BearCat</u> will locate books and journals owned by Baylor University Libraries. Remember that books will also include diaries, letters, and other primary sources. Type in your key term ("Great Britain 19th Century" or "abolition Great Britain" or "women suffrage") followed by the word "sources" to retrieve the records of books we own on your topic. For primary source on or by an individual, use the person's last name followed by any of the following words: "sources" or "diaries" or "letters" or "correspondence" ("Gandhi correspondence," "Ruskin letters,"); this also works for an era: "Victorian diaries," for example. Once you have a list of results, you may limit your search to English language



materials by using Modify Search the button at the top of the page.

<u>Empire Online</u> – full-text resource of documents, scholarly essays, chronologies, and biographies covering 1492 – 1969. The documents section will contain the primary sources, the remaining sections are of secondary source material.

<u>In the First Person</u> is a database indexing journals, diaries, oral history projects, letters, and personal narratives in English. Some materials indexed are freely accessible. Researchers can search by keyword, by date, by city or country, or by particular collections (called "repositories"). The narratives are of persons of all social standing and experiences.

<u>Newspapers</u> – there are several online or digital collections of historical newspapers including: <u>The</u> <u>Times (of London) Digital Archive, 1785 – 1985; The New York Times, 1851 – 2004</u> (ProQuest Historical Newspapers collection); and <u>African American Newspapers Online</u> (19th Century).

<u>C19</u>, <u>The Nineteenth Century Index</u> – index and some full-text to the Anglo-American world from 1790 – 1919; full-text access is complemented by an extensive microfiche collection of the primary documents. The microfiche is kept in the Jones Library Microfiche collection. When looking for the microfiche collection as a whole search by title for "nineteenth century general collection."

<u>The Victorian Web</u>. <u>http://www.victorianweb.org</u>. 3 September 2007. Originally provided contextual information for an undergraduate course in Victorian literature at Brown University, this web site has become an independent resource for all aspects of the Victorian era (literature, gender, social and intellectual history, science and technology, religion, etc.). Contents include essays, timelines, bibliographies, and visual materials.

Databases for Locating Scholarly Articles in Journals and Essay Collections

<u>Historical Abstracts</u> – covers world history from 1450 – present. Contains links to full-text articles where these exist. Can limit search by language. Primary resource for scholarly articles in history.

<u>America: History and Life</u> – the counterpart to <u>Historical Abstracts</u> for the North American continent. Primary resource for scholarly articles in American and Canadian history.

<u>ATLA Religion Database</u> – index with linked full-text to popular and scholarly articles in religion, religious history, and theology.

<u>Essay and General Literature Index</u> – lists articles published in <u>books</u> (as opposed to periodicals) and other collections of essays (English language materials only)

MLA International Bibliography - index only to scholarly articles in all languages and literatures.

<u>Periodicals Index Online</u> – broad subject coverage in the humanities, social sciences, and arts across more than 300 years of published work.

<u>World History Collection</u> – provides full-text coverage of history topics from approximately 150 journals, many scholarly. Can limit search to academic journals.

Techniques for Successful Searching

- 1) Search for ordinary people using the "Last name, First name" format.
- 2) When searching for rulers of countries you may need to search by their regnum name ("Victoria, Queen of Great Britain, 1819-1901"), by their birth names, or by combining their regnum name with the subject term "history" or the country name (ex: "Victoria" and "Great Britain" and "history" all in subject fields).
- 3) Any subject is likely to have an encyclopedia and a dictionary relevant to your work. To find these:
 - a) search BearCat in <u>keyword index</u> for the term you want with the word "encyclopedia" (England dictionary)
 - b) The same is true of the terms "sources" (for primary resources), "bibliography" and "biography" ("d:Victorian and d:bibliography; or d:19th Century d:England d:travel*)
 - c) Putting "d:" before the words will ensure that they appear only in the subject listing for the book
 - d) using "*" as the last character in a word will search for plurals or variant ("travel*" retrieves "travel," "travels," "travelers," "travel literature," etc.)
- 4) When using <u>print</u> indexes (the precursors to databases) many of these same techniques will still be used, but there are controlled vocabulary terms you may need to use; please speak with one of the librarians (in either Jones Library or the Armstrong Browning Library) for help as needed.
- 5) MOST IMPORTANTLY: if you keep coming up with either nothing pertinent or too much info, please come speak with me or one of the other Reference Librarians, we can help you reduce your frustration.
- 6) EVEN MORE IMPORTANT: START YOUR RESEARCH NOW!!!!!!!

Online coverage is from 1991 2003. The entries for books also index any scholarly reviews of the book. For the most current information in the areas of literature and language consult the *MLA International Bibliography*.
