I fully understand that Baylor University and/or Choicepoint Inc. may be requesting information from public and private sources about any of the information noted earlier in this paragraph, and I freely give my consent for Baylor University and/or Choicepoint Inc. to do so.

I understand that I have the right to receive notice about the nature and scope of any investigative consumer report requested within five days after Baylor University receives my request or five days after the investigative consumer report was requested, whichever is later. I also understand that before I am denied employment based, in whole or in part, on information obtained in the investigative consumer report, I will be provided a copy of the report and a description in writing of my rights under the Fair Credit Reporting Act. I understand if I disagree with the accuracy of any information in the report, I must notify Baylor University within five business days of my receipt of the report. If I notify Baylor University within five business days of the receipt of the report that I am challenging information in the report, Baylor University will not make a final decision on my employment status until after I have had a reasonable opportunity to address the information contained in the report.

I hereby consent to this investigation and authorize, without reservation, any one contacted by Baylor University and/or Choicepoint Inc. to furnish the information as stated above. In order to verify my identity for purposes of the background investigation I am voluntarily releasing my date of birth for my own behalf and fully understand that age is not a consideration of employment. In addition, I agree that a photocopy or telephonic facsimile of this authorization shall be valid as the original.
