Summer 2017 Honor Code Violations Report

<u>Alleged Violation</u>: Plagiarized. Date of Violation: 5/10/2017

> **<u>Decision</u>**: Guilty <u>Sanction</u>: Received a ''0'' for the paper and an ''F'' for the course. Another violation will result in suspension for two long semesters.

<u>Alleged Violation</u>: Plagiarized and submitted an earlier work for credit. <u>Date of Violation</u>: 5/12/2017

Decision: Guilty

Sanction: Received an "F" for the assignment and the course. The "F" will be permanently calculated in the cumulative GPA. A further violation will result in suspension for at least one long semester.
