

Summer 2017 Honor Code Violations Report

During the Summer 2017 semester, there were 19 reported violations of the Honor Code. 7 of these cases proceeded to Honor Council hearings. The other 12 cases were handled by faculty. One case is still pending.

HONOR COUNCIL CASES:

Alleged Violation: Altered or falsified a university document.

Sanction: Suspended for 2 semesters.

Alleged Violation: Took a test for another student.

Decision: Guilty

Sanction: Suspension for one year.

Alleged Violation: Plagiarized.

Decision: Guilty

Sanction: Received a "0" for the paper and an "F" for the course. Another violation will result in suspension for two long semesters.

Alleged Violation: Plagiarized and submitted an earlier work for credit.

Date of Violation: 5/12/2017

Decision: Guilty

Sanction: Received an "F" for the assignment and the course. The "F" will be permanently calculated in the cumulative GPA. A further violation will result in suspension for at least one long semester.

Alleged Violation: Offered as one's own work the work of another.
