Job Description (including hours and responsibilities)	The Mobile Crisis Outreach Team (MCOT) Rapid Response team provides community-based crisis intervention and post hospitalization follow up to children and adults experiencing a mental health crisis. MCOT Rapid Response is an expansion o f the MCOT program. This program includes 18 Crisis Teams. Under the general direction of the Unit Director or designated staff, Crisis Teams composed of a LPHA (LMFT, LCSW, LPC) and Care Coordinator (Bachelor Level Clinician) respond to mental health crisis calls in the field when The Crisis Call Diversion counselors at the 911 Houston Emergency Center send a referral. Crisis Teams complete crisis assessments, safety plans, and if individuals need a higher level of care, transport voluntary individuals to psychiatric hospitalization follow up, submit referrals for linkage, and provide education on mental health services to members of the community. • Must have basic knowledge of principles of the development, implementation, and documentation of individual care and treatment for a wide range of psychiatric conditions. • Must be familiar with local behavioral health providers and hospitals in the area served by the Agency. • Must have strong communication skills, listening and interpersonal skills. • Written documentation must be clear, concise, and well-constructed. • Must be able to work respectfully and maintain professional boundaries with other disciplines. • Must have effective time management and organizational skills. • Must be able to enter required documentation into a database and online medical record. •
