Range of Duties: The FSP will be prepared to provide the following services: group, individual, and family therapies covering a wide range of psychosocial concerns; consultation to school personnel and families on a variety of behavioral and socioemotional issues; diagnosis and assessment; crisis intervention; attendance and advocacy at school meetings. Intake and Screening: The FSP will determine which clients are appropriate for which services by using assessment/diagnostic techniques. This may be done in conjunction with school-based personnel. Consultation/Crisis Intervention: The FSP will provide consultation and crisis intervention for those families seeking enrollment or already enrolled in services.
