Job Description (including hours and responsibilities)	Unbound Houston's advocacy project will provide crisis response advocacy and comprehensive case management services for minors, transitional youth and adults leaving the life of sex trafficking in Brazoria, Galveston and Harris Counties. Through its advocacy program, Unbound Houston will collaborate with other members of the Brazoria County United Front Coalition, existing members of the Galveston Resource and Crisis Team, as well as TRIAD to ensure a child-centered, trauma-informed continuum of care. This type of multi-disciplinary team (MDT) continuum of care is becoming known as best practice in the field of child sex trafficking and provides the strongest chance for complete and lasting restoration for victims. Advocates are an essential part of the continuum of care, from immediate intervention to long-term restoration. Unbound Houston will recruit, screen, train, engage, and super vise advocates. These advocates will provide 24/7 on-call crisis response and ongoing case management, victim advocacy, and emotional support for minors and transitional youth sex trafficking survivorsGenerally 40 to 45 hours/week, usually 8:30 am -5:00 pm but flexible based on preferences -Availability on weekend and weeknights required -Advocate will engage in an in person crisis response immediately upon identification or recovery by law enforcement, hospital personnel, interagency advocates, school personnel, etc. and continue in a trust based relationship with survivors, providing goal orientated case management with resource linkage for self sustainment and full restorationThe Advocate will work approximately 40-50 hours per week due to rotating on call dates

	for an agreed upon salary The Advocate will be on call 2-3 nights per week according to the on call rotation On call duty requires the Advocate to be in possession of the Unbound 24/7 response line phone, ready to respond to advocacy duties and to be onsite with the victim within 90 minutes for crisis intervention calls. On Call rotation requires but is not limited to one evening a week, at least one three day weekend per month, and rotation of on call holidays Services will include case management to help meet the child's medical and behavioral health needs, hospital, law enforcement and judicial/court accompaniment, emotional support, arranging transportation, and as appropriate, support to the child's or transitional youth's non-offending family members.
