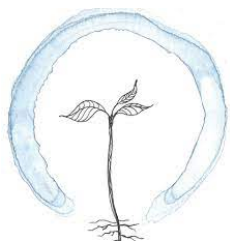

JOB DESCRIPTION: COUNSELOR

Reports to: Executive Director

Benefits and Compensation: Competitive pay, PTO, training reimbursement stipend, clinical supervision, flexible schedule, and generous health care stipend (health care stipend for full-time employees who are primary insurance holders), and more!

Job Function: Provide professional counseling that may include individual, couples, family counseling, and group sessions with Redemption Counseling Center.

Requirements:

- A. Have a master's degree in counseling, social work, or marriage and family therapy and be clinically or provisionally licensed by the Board of Behavioral Health Examiners in Arizona
- B. Demonstrated clinical aptitude and fit the culture/values at Redemption Counseling Center

Responsibilities: Maintain 22(schedule a minimum of 24) clients (full-time), 12 clients (part-time) per week working at least two days per week, with a goal of maintaining a 90% retention rate.

- A. Sessions last 50 minutes.
- B. Prompt documentation (within one week from session) and note-taking, including timely completion of the Initial Intake form after the first session.
- C. Prepare for sessions by reviewing notes, reviewing best practices, and strategizing.
- D. Abide by Professional Code of Ethics.
- E. Return urgent calls/e-mails of clients within 24 business hours.
- F. Terminate cases on a timely basis as needed.
- G. Consult therapists and doctors as needed.
- H. Meet individually with Supervisor to engage in case consultation and support on cases(minimum of one hour of clinical supervision per 20 clients seen), attend monthly staff meetings and consultation groups.

Expectations:

- A. Demonstrate strong assessment skills in the physiological, situational, and intra-psychic perspectives.
- B. Desire and ability to integrate client's faith and spirituality into therapeutic practice (where requested and appropriate).
- C. Be a racial justice ally, competent in working with clients and colleagues from a diverse background.
- D. Demonstrate strong interpersonal skills, with a desire to be collaborative and affirming of other members of the RCC team.
- E. Maintain active licensure in the state of Arizona with the Board of Behavioral Health
